- 8. A review of the performance of the group, to the extent necessary for a reasonable understanding of the group's business. It must include a discussion of the following:

  - (b) any material factors that affected the cash flow, working capital, assets or liabilities of the group during the current financial period reported on.

The Group specialises in the design, fabrication, installation and maintenance of antiricochet ballistic protection systems for firearm shooting ranges and tactical training mockups used by military and law enforcement authorities in Southeast Asia and the Middle East.

## **Review of the Group's Performance**

#### Revenue

Our revenue increased by approximately \$\$1.4 million or 27.0%, from \$\$4.8 million in the nine months ended 30 September 2018 ("9M2018") to \$\$6.2 million in the nine months ended 30 September 2019 ("9M2019"). The increase in revenue was mainly contributed by the design, supply and installation of an underwater training facility in Southeast Asia and ad hoc works from existing maintenance customers.

## **Project and production costs**

Our project and production costs increased by approximately \$\$0.5 million or 14.4%, from \$\$3.3 million in 9M2018 to \$\$3.8 million in 9M2019. The increase in project and production costs was in line with the increase in revenue.

## **Gross profit**

As a result of the foregoing, our gross profit increased by approximately \$\$0.8 million or 54.6%, from \$\$1.5 million in 9M2018 to \$\$2.4 million in 9M2019.

#### Other operating income

Our other operating income decreased by approximately \$\$139,000 or 67.1%, from \$\$207,000 in 9M2018 to \$\$68,000 in 9M2019. The decrease in other operating income was mainly due to the decrease in foreign exchange gain and grants received from various government agencies.

#### **Employee benefit expenses**

Our employee benefits expenses remained stable at approximately S\$2.4 million in 9M2018 and 9M2019.

#### **Depreciation expense**

Our depreciation expense remained stable at approximately \$\$1.1 million in 9M2018 and \$\$1.0 million in 9M2019 respectively.

## Other operating expenses

Our other operating expenses decreased by approximately \$\$0.3 million or 13.7%, from \$\$1.7 million in 9M2018 to \$\$1.4 million in 9M2019, primarily due to the decrease in foreign currency exchange loss and marketing expenses.

#### **Finance costs**

Our finance costs decreased by approximately \$\$37,000 or 11.2%, from \$\$331,000 in 9M2018 to \$\$294,000 in 9M2019. The decrease in finance cost was mainly due to decrease of the term loan average interest rate from 2.93% in 9M2018 to 2.48% in 9M2019.

## Net loss for the period

As a result of the foregoing, our net loss narrowed by approximately \$\\$1.0 million or 26.3\%, from \$\\$3.8 million in 9M2018 to \$\\$2.8 million in 9M2019.

#### **Review of the Group's Financial Position**

#### **Current assets**

Our current assets decreased by approximately \$\\$3.2 million from \$\\$13.5 million as at 31 December 2018 to \$\\$10.3 million as at 30 September 2019. The decrease in current assets was mainly due to the decrease in, (i) cash and cash equivalents of approximately \$\\$3.9 million, primarily due to payment of dividend, repayment of bank loans and finance lease, advance payment made to supplier for the purchase of material and payment for the purchase of treasury shares, (ii) contract assets of approximately \$\\$0.1 million, and (iii) inventory of approximately \$\\$0.1 million, which was partially offset by an increase in trade and other receivables of approximately \$\\$0.9 million.

#### Non-current assets

Our non-current assets decreased by approximately \$\$1.2 million from \$\$28.9 million as at 31 December 2018 to \$\$27.7 million as at 30 September 2019, primarily due to the depreciation of property, plant and equipment of approximately \$\$1.0 million and amortisation of intangible assets of approximately \$\$0.2 million.

#### **Current liabilities**

Our current liabilities decreased by approximately \$\$0.4 million from \$\$2.0 million as at 31 December 2018 to \$\$1.6 million as at 30 September 2019. The decrease in current liabilities was mainly due to the decrease in trade and other payables.

#### Non-current liabilities

Our non-current liabilities decrease by approximately \$\$0.6 million from \$\$15.0 million as at 31 December 2018 to \$\$14.4 million as at 30 September 2019, primarily due to the repayment of bank loans and lease liabilities.

#### **Review of the Group's Statement of Cash Flows**

## Net cash used in operating activities

Net cash used in operating activities was approximately \$\$2.6 million in 9M2019, which was a result of operating cash outflow before movements in working capital of approximately \$\$1.3 million and interest payment of approximately \$\$0.3 million, and an increase in working capital of approximately \$\$1.0 million. The increase in working capital was primarily due to the increase in trade and other receivables of approximately \$\$0.9 million, decrease in trade and other payables of approximately \$\$0.3 million, partially offset by a decrease in the contract assets of approximately \$\$0.1 million and inventory of approximately \$\$0.1 million.

## Net cash used in investing activities

Net cash used in investing activities was approximately \$\$6,000 in 9M2019, which was primarily due to an increase in fixed deposits pledged of \$\$5,000 and increase in property, plant and equipment of \$\$4,000, partially offset by a proceed from disposal of property, plant and equipment of \$\$3,000.

#### Net cash used in financing activities

Net cash used in financing activities was approximately \$\$1.3 million in 9M2019, which was primarily due to purchase of treasury shares of approximately \$\$0.1 million, dividends payment of \$\$0.6 million, and repayment of bank loans and finance lease of approximately \$\$0.6 million.

The Group continues to pursue opportunities to design and engineer customised training solutions for existing and potential customers as law enforcement related customers respond to the threat of terrorism and extremism. The Group is also actively responding to enquiries and requests for tenders from authorities in Southeast Asia and the Middle East. Notwithstanding the competitive market conditions, the Group remains optimistic of its ongoing discussions and is committed to secure more contracts in both Southeast Asia and the Middle East.

The Group is working to strengthen its partnerships with defence contractors, equipment suppliers and consultants to participate with them either in joint tenders, or collaboration for successful tenders. In addition, the Group is also working with the relevant authorities to expand its portfolio of maintenance service contracts and grow its recurrent revenue base.

Given that a major portion of the Group's business is project based, the revenue contribution from projects may vary from quarter to quarter, depending on the size and scope of the projects on hand and their completion schedules. Nonetheless, the Group will continue to focus on ensuring effective cost management of its projects and production costs to achieve a sustainable operating performance.
